
About ERBER Family Foundation

Background

Erber Family Foundation Officially authorized to register for the establishment on April 19, 2021. Foundation administration at the beginning started with 4 committees, consisting of 1. Mrs. Piyapa Erber, Chairman 2. Mr. Hassadin Insombat, Vice-Chairman 3. Ms. Charanda Rungsittitanaporn, Secretary and 4. Ms. Chanya Butkhort, Treasurer. Subsequently, the committee approved to invite Prof. Dr. Erich Erber to be an advisor, and appointed 2 additional committee members, Mrs. Sasakorn Pleumchai, as Vice-Chairman, and Mr. Boonprom Pleumchai as Secretary. The Department of Provincial Administration considered and approved the appointment of additional committees on 29 November 2021.

Objectives of the Founder

Professor Dr. Erich Erber, Founder and Advisor who is a major contributor to the Foundation's initiatives has a strong desire to support education for disadvantaged children who facing family problems or lack of caregivers to receive quality education that meets international standards to grow up as an adult, be able to take care of themselves and their families and contribute to society in the future. The Foundation has set the goals of operations as follows.



- Provide assistance and sponsorship for children and youth who have been affected by atrocities and violent offences against children.
- Promote, support, and operate the Foundation to prevent child and youth abuse and human trafficking.
- Operate and cooperate with other charities for the public benefit.
- Not taking any action related to politics.
- Not operate the foundation for income or profit. But it's only a charity organization.



Scholarship Granting

After being formally approved for the establishment of the Foundation on April 19, 2021, the Foundation has sponsored 16 disadvantaged children to become scholarship students of the Foundation, effective from May 1, 2021, by accepting students that Dr. Erich Erber, Founder and Advisor of the Foundation, had previously sponsored to be under the patronage of the Foundation. All 16 scholarship students were given the opportunity to study at Panyaden International School, Hang Dong District, Chiang Mai Province in various classes together with other students at the school. The foundation has arranged two houses for the children near the school, separated between boys and girls along with providing childcare teachers and a housekeepers to take good care of the children. The Foundation is responsible for all expenses including tuition fees, extra tuition fees, meals, accommodation, wages for childcare teachers and housekeepers, medical expenses, as well as various expenses for online learning at home due to the COVID-19 outbreak situation.

Message from the Chairman

This Erber Family Foundation Annual Report 2021 is the first edition. The Foundation has gathered information on key operations and activities to disseminate the Foundation's operations and used in the Annual General Meeting 2021.

Erber Family Foundation has applied permission to establish a charitable foundation at the end of 2020 and was officially granted the permission of establishment as a foundation on 19 April 2021, with the main objective of aiding and support to disadvantaged children who suffer from family problems to receive equal and quality education and have been cultivated with good morals, ethics, and grow up to be adults and have a career to support themselves and their families and contribute to society in the future according to the intention of Professor Dr. Erich Erber, the founder of the Foundation.



After receiving permission to establish a foundation, the committee has taken action to accept 16 scholarship students who Dr. Erber has sponsored from 2019 and 2020 to be under the care of the foundation, and still attending Panyaden International School, Hang Dong District, Chiang Mai Province as before, because Dr. Erber has a passion for the concept of the Panyaden International School that focuses on teaching based on Buddhist principles, cultivating children in harmony with nature. The Foundation is responsible for all expenses including the tuition fees, extra tuition fee, accommodation, meals, wages of childcare teachers and housekeepers, etc. The Board of foundation has always monitored the well-being of the children as if they were the children of the family, by communicating with childcare teachers and the children regularly through various social media, video conferencing, including traveling to meet children by ourselves on various occasions.

Throughout the year 2021, the corona virus disease 2019 or COVID-19 outbreak has been a crisis that affects the well-being and learning of the children. The Foundation cooperates with teachers and schools in every way to keeps children safe from this virus. There are times when children are required to stay at home and study online, causing a lot of adapting to the situation for both children and teachers but we managed to get through this well throughout the year 2021.

For 2022, the Foundation continues to support children under the constant support of Dr. Erber, who wants to see the children grow and develop in a better way. This requires great care and attention from all members of the Foundation, committees, childcare teachers, housekeepers, including teachers at school, and others involved from Panyaden International School.

Finally, on behalf of the Erber Family Foundation Board of Directors, I would like to thank everyone who has contributed to make the Foundation's activities successful in accordance with the objectives of the Foundation, especially teachers and housekeepers who have always devoted themselves to taking care of children amid the severe outbreak of the Covid-19 and hope to receive cooperation from everyone again in 2022 and beyond.

Our Supporters

In fiscal year 2021, the Foundation received various donations and supports from the following benefactors:

3. Erber Biotech (Thailand) Co., Ltd. donated 20 sets of alcohol spray, hand sanitizer, mask, cloth bag, and Rotting pencil.







4. SAN-Group donated 20 sets of notebooks, pens, and masks







5. The committee of the Foundation, led by the Chairman, had planted jasmine rice on an area of over 3,200 sqm. The rice was planted in July and can be harvested in December 2021. The rice is then milled and packed in bags to be donated to the foundation for various purposes, such as cooking rice for children or giving in return to external donors.









Activities in 2021

Online Learning at home: Computer equipment and headphones borrowed from schools were used during a time when Chiang Mai province delayed the opening of schools due to the higher number of COVID-19 infections in Chiang Mai. The childcare teachers taking turns to take care of, and there are nurses sent by Panyaden International school to help take care of them.





Pfizer Vaccination: For children up to 12 years of age before December 6, 2021. Eligible children were Sow, Saint, Venus, Tin-Tin, Jiseong, Max and Jacob. All Children are in good health, without any side effects. The Foundation has supported ATK testing kits for weekly testing in accordance with the school's requirements. An estimated initial use of 15 sets on the opening day and 13 sets every week.







Fire Escape Drills: Another activity that children pay attention and focus on training to be able to use it if it actually happens.







Activities during the semester break: This year the children will be mainly at home due to the covid situation. The activities will focus on teaching computers for online learning, volunteer work, and doing activities at home together. There are also recreational activities outside when easing of measures such as taking children to exercise in the park, having fun and develop skills with clay work, etc.













Activities with the school: We encourage children to see the important and cooperate with school activities such as the Semester Breaks Party, which are assigned the children to prepare gifts that they already had without buying new ones to exchange with their friends and to bring desserts to eat together. The children were so excited, they help each other to made desserts and shared them with their friends at school.



Birthday Party: We sometime hold the simple birthday parties by just letting the birthday children choose the evening menu for that day and have friends sing a birthday song for them. In case there are many birthdays in the same month, we may organize a special birthday party in a day.







Relationships within our family: The Erber Family Foundation's relationship is in a warm and close relationship. We look for opportunities to meet and communicate regularly either directly in person or online. On special occasions such as Mother's Day, New Year's Day, children often organize performances to bring happiness to our family.



Children's Painting Skills: After the teacher shared the pictures of rice farming in various steps to the children, they learned that the Foundation committee put in effort in planting rice to donated to the foundation. The children were impressed and determined to draw pictures to be used to make packaging of rice either for selling or giving as a gift to donors.
